- Provide care and support to babies, toddlers, and young children



#### **Purpose of this Qualification**

This qualification will enhance the scope and quality of Victim Empowerment services in South Africa and provide Victim Empowerment service providers, primarily in the NGO and CBO sector, with the necessary knowledge and skills to provide direct services and co-ordinate Victim Empowerment programmes in their organisations.

The qualification is intended for service providers in the Victim Empowerment sector. These include community developers, auxiliary social workers, and health care workers, experienced volunteers, members of the organisation (other than psychologists and social workers) who would co-ordinate Victim Empowerment programmes within their organisation. The qualification is not intended for individuals wanting to do long-term counseling and individual counseling services, but for individuals working under the auspices of an organisation under the supervision of an appropriately trained mental health care professional.

The learner assessed as competent against this Qualification will be able to:

- Co-ordinate Victim Empowerment programmes, campaigns, and activities.
- Support, coordinate and maintain strategic partnerships.
- Support management in the planning and implementation of Victim Empowerment programmes and initiatives.
- Mentored and coordinated volunteer activities.
- Provide trauma support under supervision.

Qualifying learners could follow a career in:

- Counselor
- Team Leader for Support Group
- Coordinate Victim Empowerment Services

#### **Exit level Outcomes**
